**ROUTES TO THE SHOW**

**FROM THE NORTH OR SOUTH ON I-5** - Take the Auburn Exit (Hwy 18). Go to Auburn and take the Enumclaw Exit to Highway 164. Follow the signs to Enumclaw (Highway 410), just before Enumclaw, turn right on 244th, go to 456th and turn left. It becomes Warner. Stay on Warner to the fairgrounds.

**GOING SOUTH ON I-405 OR COMING FROM THE RENTON AREA** - Go east on Maple Valley Highway (Highway 169), go through Black Diamond, continue on until 416th SE, turn left, then follow signs to the fairgrounds.

**JUNIOR SHOWMANSHIP COMPETITION**

**NOVICE JUNIOR CLASS** - For Boys and Girls at least 9 and under 12 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

**NOVICE INTERMEDIATE CLASS** - For Boys and Girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

**NOVICE SENIOR CLASS** - For Boys and Girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

**OPEN JUNIOR CLASS** - For Boys and Girls at least 9 and under 12 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

**OPEN INTERMEDIATE CLASS** - For Boys and Girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

**OPEN SENIOR CLASS** - For Boys and Girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

**MASTER CLASS** - For Boys and Girls at least 9 and under 18 years of age on the day of the show and who have won ten (10) first place wins in an Open Class, with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be consistent with the eligibility dates for the AKC Eukanuba National Championship. All juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed, all participants return to the Open Class to compete for the following year.

**NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry.**

**BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.**

## AKC NATIONAL OWNER-HANDLED SERIES - SATURDAY

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.



**“DON'T FORGET TO CHECK THE OWNER-HANDLED BOX ON THE ENTRY FORM IF ENTERING THIS COMPETITION.”**



All dogs that are owner-handled and are not solely owned or exhibited by professional handlers\* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the steward's book & the catalog. **Dogs must be handled throughout the breed level competition for the regular show by an eligible owner\*. Professional handlers, household members and assistants to current professional handlers may not exhibit the dog in any breed competition during the entire show.**

Owner-Handled Best of Breed will be selected from the dogs that are competing in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed, or in Best of Winners competition.

*\*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay or received payment for handling a dog within the last five years.*

Best of Breed (Variety) Competition

The following categories of dogs may be entered and shown in Best of Breed (Variety) Competition: Dogs that are Champions of Record. Dogs which according to their owner's records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs with championships that are unconfirmed is limited to a period of 90 days from the date of the show where a dog has completed the requirements for a championship according to the owner's records. If at the end of the 90 day period the championship of a dog has not been confirmed by the American Kennel Club, no further entry of the dog for Best of Breed competition is to be made until its championship has been confirmed by AKC.

**NON-REGULAR (ADDITIONAL) CLASSES Involving Single Dog Entries**

**VETERAN DOG CLASS** - A Class for Dogs seven (7) years or older.

**VETERAN BITCH CLASS** - A Class for Bitches seven (7) years or older.

*Note: Veteran class entrants MUST be intact. Spayed or neutered dogs/bitches are not eligible. Winners of the Veterans classes are eligible to compete for Best of Breed/Variety.*

**NON-REGULAR (ADDITIONAL) CLASSES Involving Multiple Dog Entries**

As the judge's decision in the Non-Regular Classes involving Multiple Dog Entries is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won these classes.

**STUD DOG CLASS** - For Stud Dogs and two, but not more than four of their Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in th ring with their Get. The owner of the Stud Dog need not necessarily be owner of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Get must be entered in a regular class, Best of Breed (Variety) competition, or some other non-regular class.

**BROOD BITCH CLASS** - Same as for the Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

**BRACE CLASS** - Two dogs with at least one or more common owner. The Dogs comprising a Brace must be named at the time of entry. If a dog which is to be part of a Brace is not entered in another class it must be entered for "Brace Class Only". Full particulars must be given for each dog on individual regular entry forms. An entry form for a dog entered in another class and entered as part of a Brace must be marked in the space provided for Additional Classes - "Brace Class". If more than one Brace is entered by the same owner the dog comprising EACH BRACE must be so designated- "Brace No.1", "Brace No.2," etc.\*

**The above classification is provided for all breeds (and varieties). Additional divisions, i.e. (age, color or weight) are in the breed list and must be indicated on the entry.**

Competition is offered for dogs & bitches 7 years & older (divided by sex) entered and exhibited in the veteran classes to compete for Best of Breed Veteran through Best in Show Veteran. Veteran classes will be judged prior to Best of Breed. Veterans that win Best of Breed in the conformation classes are automatically Best of Breed Veteran. **Neutered dogs & spayed bitches are not eligible to compete.** Veteran Best of Breed will be judged following the regular classes in each breed, unless determined as noted above. Veteran Variety Groups will be held. Best Veteran in Show will be judged prior to Best in Show.

The following breeds must be judged on a ramp through all levels of conformation competition: Sussex Spaniels, Basset Hounds, Bulldogs, Chinese Shar-Pei and Chow Chows.
